Dear Mevlüt,

I have the honour to write to you following my discussion in Bueno Aires with His Excellency Mr Recep Erdogan, President of the Republic of Turkey, about Turkey's membership of the International Agency for Research on Cancer (IARC), the cancer agency of the World Health Organization (WHO). I am recently in receipt of a letter on this subject from Professor Emine Alp Mese, Deputy Minister of Health, notifying me of the withdrawal of Turkey from its membership of IARC. A copy of this letter is attached for ease of reference.

Turkey joined IARC as a Participating State in 2011 and brings a vitally important regional representation to the IARC Governing Council, with a unique perspective among the 26 Participating States which helps shape the Organization's global cancer research agenda. Turkey's outstanding leadership in the fight against noncommunicable diseases, including cancer, aligns closely with IARC's mission within WHO of conducting "cancer research for cancer prevention". In fact, IARC collaborates with scientists worldwide to provide the scientific evidence on which cancer control policies, guidelines and recommendations are based.

Turkey has recently made major strategic and pioneering advances in protecting the health of its citizens through the creation of the new Health Institutes of Turkey, of which the Turkish Cancer Institute is one. Earlier this year, Dr Christopher Wild, Director of IARC, received a senior-level delegation from the Turkish Cancer Institute, and a number of new opportunities for collaborative research were identified. Turkey also hosts the IARC Regional Hub for Cancer Registration, supporting cancer registry development in surrounding countries where expertise is currently lacking. These developments substantiate remarkable potential for continuing and enhanced cooperation between Turkey and IARC at this critical time for the global cancer research agenda, as well as the further development of Turkey's Cancer Institute.

Turkey has a vital strategic presence on the IARC Governing Council as a Participating State. Turkey's withdrawal would represent a major loss to both IARC and WHO, and would result in a missed opportunity for cancer researchers in Turkey to participate in wider international collaborations, thus impairing global cancer research efforts.

For these reasons, I respectfully request you to reconsider the decision to withdraw Turkey from its role as an IARC Participating State. WHO stands ready to support Turkey's continued engagement and participation in IARC, and will continue to support Turkey in your country's fight against Noncommunicable diseases.
